SIRAGUGAL SCHOLARSHIP NOTIFICATION (No.01/2021-2022)

BACKGROUND:

The Journey of Siragugal Trust, an officially recognized non-profitable organization began from the classrooms of Coimbatore Institute of Technology. Engineering graduates who passed out from CIT in the year 2017 have now taken a stand to raise their voice against social issues which includes supporting student's educational needs.

OBJECTIVE:

Objective of Siragugal Scholarship is to fund the economically backward students who are struggling to manage their academic expenses. Siragugal Trust selects the students who are in need of the scholarship based on certain criteria in their first year and takes care of their academic expenses up to their final semester.

ELEGIBILITY:

To avail the Siragugal Scholarship, the following conditions should be met:

- The Annual Income of the student's family should be less than Rs.1,00,000/-.
- Scholarship eligible for B.E/B.Tech Students (2021-2025) of Coimbatore Institute of Technology.

PROCEDURE FOR APPLYING THE SCHOLARSHIP:

- Students eligible to avail the scholarship can fill the scholarship e-form which will be available in CIT college official website (<https://www.cit.edu.in/>) from 20th December 2021.
- Students should submit the scholarship e-form after filling all the necessary details along with the photocopies of the below mentioned documents.
- Students who are selected for the scholarship will be notified after the verification of the details furnished by them.

- Self-Attested Copy of Community Certificate
- Self-Attested Copy of Income Certificate

- Self-Attested Copy of Certificate of Disability (If Applicable)

CONDITIONS FOR THE SCHOLARSHIP:

- Scholarship will not be given to more than 3 students.
- Scholarship forms of the students who provide incorrect information will be rejected.
- Scholarship forms submitted after the last date of submission will not be accepted.
- Field verification will be performed based on the details furnished by the students.
- Academic performance of the students who are provided with the scholarship should be consistent and scholarship can be cancelled at any time if the student's academic performance seems to be affected.
- The Trust will provide funds only for College fees. All the other expenses (Hostel fees, Exam fees, etc.) will not be covered under this programme and have to be borne by the respective student.

Note:

Students availing the scholarship will be selected based on various criteria which shall not be disclosed.
